1. Moral Report:

The president read out the moral report (attached). He thanks the Secretaries General of the Office and the administrators. He also thanks and acknowledges the important work done by Béatrice BRENNEUR for GEMME, and especially for the 10th anniversary organized on June 5 and 6 at the Court of appeal and the Court of Cassation in Paris.

2. Financial Report and approval of the accounts:

The Chairman gave the floor to Jacques VERNOCHE, Treasurer, which presents the financial report and the situation of the accounts on December 31 2013. The amount of revenue received from contributions in 2013 is Euros 17 080 Euros

Euros 2 580 contributions collected in 2013 under the 2012 including Euros 2266 paid by the Italian section at the request of the Board following the difficulties encountered in this section.

The total amount of expenses incurred or paid is Euros 7228, including:

- Euros 7.095 for travel expenses,
- Euros 133 various expenses

We remind you that it was ending the mission of the accounting firm at 31 December 2012, this is the reason why this expenditure mainly limited to travel expenses.

2013 result is Euros 9.853.

The bank balance at December 31st, 2013 is Euros 47.348.

Liabilities:

The results of cumulative prior years are Euros 36.927.

The result for 2013 is Euros 9.853.

The remaining debts are Euros 569.

The financial report and accounts are approved unanimously.

3. Discharge of the members of the Board for the execution of their mandate:

The General Assembly gave the governing discharge for the past period.

4. Elections of the administrators:

The Secretary General said that the representatives of the national sections are full right members of the Governing Council. A national section is incorporated as it consists of 7 members. Other countries members of the European Union which do not consist in national section due to lack of sufficient representatives, or other countries outside the European Union, can be represented in the Board of Directors, depending of the case, in the capacity as elected directors or by participating in the activities of GEMME as observers.


